### **Guidelines for the Jurying Process:**

- All prospective ACG artists are required to present their work for review and acceptance to our Gallery Screening Committee. Their collective decision will be final.
- All art submitted must be accompanied by the artist's resume and biography (See Member Application)
- Art submitted must be presented in a professional manner. No unframed or unfinished art will be accepted for review, except for work intended to be displayed without a frame.
- Acceptance of new artists will be based on:
  1. Execution and craftsmanship
  2. Aesthetic quality and originality
  3. Compatibility with existing members' work
  4. The gallery's current need for a specific art medium to round out the gallery's range of offerings
- Art presented for jurying must be the same type/media (e.g., jewelry, wood sculpture, blown glass, 2D wall art) as intended for sale in the gallery. If selling prints or giclées of your work (photos are considered prints), you are required to have at least one original for sale on the wall at all times. You must be the original photographer and may only show photos you have taken.
- When submitting works for more than one category, clearly indicate which pieces are intended for which category. Note: Types and mediums of work not presented for review at the time of a screening, will need to be juried at a later date before being placed in the gallery.
- A minimum of five pieces must be submitted for review. Additional pieces may be presented to fully demonstrate the types of work intended for sale in the gallery. Once you are a member, you may wish to jury in additional types/media of work.
- All applicants, approved and denied, are notified upon completion of Screening Committee review.

### **Please Note:**

- If accepted, your name/medium may be placed on a waiting list due to space limitations or media requirements of the gallery.
- If accepted, the Marketing Committee may take still photographs of your artwork and may ask to film you creating your art at your studio or at the Gallery for advertising purposes.
